## **TERMS & CONDITIONS**

### Coople's 2023/24 Company Referral Scheme:

By participating in Coople's company referral scheme you fully agree and accept the terms and conditions. The referral scheme will run between 21<sup>st</sup> April 2023 – 31<sup>st</sup> December 2024. The CHF 750.- credit will be added to the referrers account once the entry criteria below has been met.

### Classification:

- Referrer = existing client with a CH Coople business account who refers a new company.
- Referee = referred contact/company.

#### Criteria:

- Offer: CHF 750.- will be added to the referrers account three days after the referee pays their first invoice.
- The referee must be a new company registered on the CH Coople platform between 21<sup>st</sup> April 2023 – 31<sup>st</sup> December 2024. The referee must not have been registered on the Coople platform before being referred through the company referral scheme.
- The referrer must be an existing client registered on the CH Coople platform and have completed at least 3 or more orders.
- The offer is only valid on referee job(s) invoiced between 21<sup>st</sup> April 2023 and up to and inclusive of 31<sup>st</sup> December 2024.
- The referee must have paid their invoice before 23:59 on 31<sup>st</sup> December 2024 for the referrer to be eligible for the CHF 750.- account credit.
- The referrer's CHF 750.- credit will be applied to their account three days after the referee pays their first invoice. The referrer will have 90 days to use their credit from this date. After 90 days, the CHF 750.- will expire and will be removed from their account.
- The referrer can use the CHF 750.- account credit against multiple invoices.
- The referrer must use their CHF 750.- account credit towards an invoice within 90 days of the credit being applied or by 23:59 on 31<sup>st</sup> March 2025, whichever is sooner.
- The referrer and referee must both have an active Coople account before the account credit is applied. An active account means the company can login and post jobs. The account will not be pending, closing, or closed.
- The referrer must have completed three or more jobs on the Coople platform to be eligible for the company referral scheme.
- The offer of CHF 750.- credit applies to distinct legal entities, not individual hiring accounts from part of the same legal entity.



Registered referrers who do not meet all the above criteria will not be eligible to receive the referral reward.

#### Other conditions:

- For the purpose of this referral scheme, the referee's first invoice must be for a job that lasts longer than four hours.
- The offer cannot be sold, it cannot be transferred to another Coople account, and is non-transferable for cash.
- Coople reserves the right to end or extend this referral scheme at any time at its discretion.
